RENTAL TERMS AND CONDITIONS

Overview

The undersigned is accountable for the operation, care, maintenance and safety of the equipment during the rental period. Any employees operating the equipment must be trained. Please review the instruction manual supplied with the equipment before operating. Follow all start-up, operating, safety and shutdown routines as described in the operating manual and online videos as provided. AJVS does not guarantee or approve any leak testing results generated by the rental equipment. The undersigned is responsible for and liable for any leak testing certification and results. AJVS is not liable for any scheduling issues due to rental unit availability.

Rental Rates

All rentals will require credit card payment or a preexisting Open Account with AJVS. Contact AJVS to set up an alternate term of payment. Rental charges will begin at the time the equipment is received or picked up by the customer. The rental will end at the time the item is returned or the day it is shipped back to AJVS as reported by the freight tracking number. Contact AJVS for extended rental rates. Rental fees are charged upon shipment of the rental equipment. Additional rental time resulting from extended or late rental returns will be charged upon return, upon requests for additional time or upon the rental return date coming past due. No credits will be provided for early returns (1 week minimum) or for lack of utilization.

Insurance, Damage, Loss or Theft

The undersigned is responsible for damage, loss or theft of the equipment during the rental cycle. Identification of any possible damage is subject to inspection by AJVS. The undersigned is responsible for payment of reasonable costs to repair or replace the equipment due to loss, theft or damage. It is highly recommended to verify business insurance coverage of rental equipment in possession. Shipping insurance is mandatory on return shipping for the value noted. AJVS reserves the right to charge the given credit card to cover the damage, loss or theft of the rental equipment. Customer is responsible to notify AJVS of any potential shipping damage so a freight insurance claim can be filed prior to return of the unit. Failure to do will void any claims for credit.

Service and Repairs

The undersigned is not authorized to perform repairs or maintenance on the equipment. All repairs or maintenance are required to be performed by or under the instruction of AJVS personnel. In the instance of equipment failure please contact technical help and support at 973-249-0854. In the event of failure on a rental unit, AJVS will deliver an additional unit (based on availability) prepaid ground and credit the rental time for down days. Customers can easily elect to pay expedited alternative shipping charges. No refunds will be given for the original freight charges as a result of freight damage or failed units.

Excessive Wear and Tear or Equipment Abuse

When operated safely and securely the equipment should undergo minimal wear and tear during the rental period. If it is determined that upon receipt and inspection of the rental equipment there has been excessive damage or abuse the customer shall be billed for repair. This includes but is not limited to contamination of the equipment by chemicals, water, or excess particles, or operating the equipment without the appropriate type or amount of lubricant.

Transportation, Storage, and Shipment

The equipment will be packed in original shipping crate to prevent shipping damage. All costs for shipping are to be paid by the customer. All items to be shipped will be insured per the indicated value. Portable leak detectors must be returned by two day delivery service. Warranty credits or replacement units will be provided free of charge in the event of a rental failure, however all shipping charges are paid by the customer.

Helium Leak Detector Operation

The leak detector shall be operated such that it will not be subject to abrupt air in-rushes or high amounts of water vapor while in test. The leak detector may possibly be moved while in operation. However, avoid excessive movement or shock while the system is in use. Leak testing rental equipment is not designed, rated or allowed for use in leak testing applications involving corrosive materials, water, high concentrations of oxygen, hydrogen or radioactive materials. Any misuse may result in equipment damage. Do not use the leak detector to sniff an item contaminated with liquids or particles on its surface. Insure the item is clean prior to sniffing.
